The Economic Development Distinguished by Excellence (EDDE) Awards were established by the members of AAED to recognize the outstanding work of their peers. The membership of AAED is responsible for nominating their peers for these awards. The value and prestige of the EDDE's is defined by the membership, through their accomplishments and commitment to the organization. Your nomination is the recognition of their efforts.

## 2025 EDDE AWARD CATEGORIES

### Economic Development Organization of the Year

This award recognizes outstanding contributions by an organization aimed at strengthening the efforts of AAED. Contributions may include the active involvement by organization staff on the AAED Board of Directors and committees, regular attendance by staff at AAED events, sponsorship of AAED and AAED events, etc. Nominations will be evaluated based on the overall impact of the organization on AAED, the development of strong relationships and community support, and contributions to the economic development profession. Eligible organizations must represent a community City or region that represents a service of the following:

- Small Organization – less than 50,000
- Medium Organization – 50,000-149,999
- Large Organization – more than 150,000
  - County nominees should apply to the category that represents their respective population.

*2024 Medium Organization of the Year - City of Goodyear*

*2024 Large Organization of the Year – City of Peoria*

### The Best of Arizona

Best of Arizona is a prestigious award presented to individuals or organizations whose dedication to economic development in Arizona has been unequalled. Nominee's contributions to economic development must have resulted in a significant statewide impact on Arizona's economy. This impact can be a sustained impact over a long period of time or the result of a singular project or achievement.

## **Economic Development Professional of the Year**

This award recognizes outstanding achievement by an economic development professional. Nominations will be evaluated based on the overall economic impact to their community, the development of strong relationships and community support, the innovation and creativity used in the process, and contributions to the economic development profession. City or regional organization nominees represent a service area with a total population of the following:

- Small – Less than 50,000
- Medium – 50,000-149,999
- Large – More than 150,000
  - County nominees should apply to the category that represents their respective population.

## **Emerging Economic Development Professional of the Year**

This award recognizes outstanding achievement by an emerging economic development professional. Nominations will be evaluated based on the overall economic impact to their community, the development of strong relationships and community support, the innovation and creativity used in the process, and contributions to the economic development profession. Additionally, this award will evaluate an emerging professional's contributions to the advancement, involvement, and empowerment of future economic developers. An Emerging Professional must be 35 years of age or under or have less than five years of direct economic development experience.

## **Tribal Economic Development Champion of the Year**

This award recognizes outstanding achievement by an individual that has positively impacted economic development efforts for one or more of the 22 federally recognized Indian tribes in Arizona. Nominations will be evaluated based on the overall economic impact to the tribal community, the development of strong relationships and community support, the innovation and creativity used in the process, and contributions to the economic development profession. Nominees do not need to be a member of a federally recognized Indian tribe to qualify for this award or an AAED member.

## **Member of the Year**

This award recognizes outstanding achievement by an AAED member (Practitioner or Provider) that has made a significant commitment to AAED through their active participation in the organization. Participation can include active involvement on the AAED Board of Directors, in AAED committees, the recruitment of new members, regular attendance at AAED events, and organizational/event sponsorship. Nominations will be evaluated based on the overall impact of the member on the organization, the development of strong relationships and community support, and contributions to the economic development profession.

Member contributions eligible for this award are evaluated during a calendar year period from January through December of the previous year (i.e. January 2024 – December 2024).

## **New Member of the Year**

This award recognizes outstanding achievement by a new member (Practitioner or Provider) that has made a significant commitment to AAED through their active participation on committee(s), recruitment of new members, and/or attendance at AAED events. Nominations will be evaluated based on the overall impact of the member on the organization, the development of strong relationships and community support, and contributions to the economic development profession.

Members joining AAED during the 18-month period from July through December of the following year are eligible for this award (i.e. July 2023 –December 2024).

## **William Lampkin Long Term Excellence in Economic Development**

This award recognizes outstanding achievements by an individual that has made significant contributions to economic development efforts in Arizona and demonstrated a sustained commitment to AAED. Nominations will be evaluated based on the overall economic impact of their efforts to Arizona, contributions of the member to the organization, the development of strong relationships and community support, and contributions to the economic development profession.

## **Workforce Practitioner of the Year**

This award recognizes outstanding achievements by an individual to Arizona's Workforce Development efforts. Nominations will be evaluated based on the overall workforce impact on the community, the development of strong relationships and community support, the innovation and creativity used in the process, and contributions to the overall economic and workforce development profession.

## **Economic Development Provider of the Year**

This award recognizes outstanding contributions by a provider organization aimed at strengthening the efforts of AAED. Contributions may include the active involvement by organization staff on the AAED Board of Directors and Committee, regular attendance by staff at AAED events, sponsorship of AAED and AAED events, etc. Nominations will be evaluated based on the overall impact of the organization on AAED, the development of strong relationships and community support, and contributions to the economic development profession. Eligible organizations must be AAED member companies in the Provider category. Eligible organizations must have at least one AAED member in the Provider category.

## Nomination Eligibility Criteria

- Nominations may only be made by members of AAED.\*
- Self-nominations by an individual or and an employee of an organization are acceptable. Self-nominations must be endorsed by an AAED member.\*
- Companies, organizations, and individuals are not eligible to win the same award two years in a row.
- Written and electronic nominations submitted on or before the nomination deadline will be eligible for consideration for all awards.
- Late nominations due to reasonable uncontrollable circumstances (technological failure, mail delay, accidents, etc) may be considered for eligibility by the EDDE Task Force.
